#### LIABILITY AND IMAGE RELEASE AND WAIVER: ALL ATTENDEES MUST SIGN THE WAIVER!

LIABILITY WAIVER: For and in consideration of being permitted to participate in The National Conference on Gambling Addiction & Responsible Gambling 2024 ("Event"), the participant, on behalf of himself/herself, personal representatives, heirs, and/or assigns (collectively, "Participant"), hereby releases, waives, discharges, and covenants not to sue the National Council on Problem Gambling ("NCPG") and its officers, directors, employees, agents, affiliates, representatives, and insurers (collectively, "Releasees"), from any and all claims, damages, losses, injuries, illness, suits, or demands (including for bodily or personal injury, death, or property damage)(collectively, "Claims") arising from or out of, or in connection with, Participant's participation in the Event or use of the Event's facilities, even though the Claims may arise out of or from, in whole or in part, the negligence or carelessness of Releasees.
