### **Mission Statement**

The Maryland Center of Excellence on Problem Gambling promotes **healthy and informed choices** regarding gambling and problem gambling through various key initiatives and partnerships.

The Center works closely with appropriate state stakeholders and brings together experts from a variety of disciplines including psychiatry, medicine, epidemiology, social work, and law.



## **Key Initiatives and Resources**

- Public Awareness: Campaigns through social media, TV, radio, public service announcements, community outreach, public awareness materials and lending library
- **Prevention Programs:** Targeted to the full age continuum and to diverse populations and at-risk groups
- Public Policy: To provide information regarding strategies to address the impact of gambling on Public Health within Maryland
- Research: To provide evidence-based data on public health aspects of gambling disorders and evaluate and develop evidence-based strategies for prevention and intervention



## **Key Initiatives and Resources**

- Free Training: On problem gambling awareness, prevention and intervention strategies with CEUs

# How to get there from here... The Maryland Center of Excellence on Problem Gambling's Peer Support Program:

A Brief History



Community Outreach, connecting with those that may be affected by gambling related harms

Peer Initiatives



Connect with persons seeking help to community resources like no cost treatment, credit counseling, selfhelp support meetings, and exclusion programs

Meet persons "where they are at" regarding their readiness to stop or limit their gambling

Gambling Awareness Presentations offered to persons currently in treatment for substance use or mental health



Warm Transferred to calls made into the Helpline [1-800-GAMBLER] who agreed to receive Peer Support

## **Peer Support for Gambling**

In FY23 (July 2022-June 2023), 285 new clients were actively served by the Center's Peers



Offer guidance and support to limit, stop or control gambling

Connecting help seekers to no cost treatment, 12-step meetings, credit counseling, voluntary exclusion program, etc.

Inspire hope and optimism navigating recovery goals



Advocate that recovery is possible through lived experience

### Maryland Addiction and Behavioral-Health Professionals Certification Board (MABPCB)

- The Certified Peer Recovery Specialist (CPRS) became an approved credential in November 2013.
- Must self-identify as a person in long-term recovery from the effects of a behavioral health disorder (*i.e. mental health, gambling, and/or substance use disorder*) for a period of two years or more.

### Maryland Addiction and Behavioral-Health Professionals Certification Board

#### Some Requirements:

- 46 total hours of Peer specific CEU's that are MABPCB approved within the following four (4) Domains:
  - *i. Advocacy Domain 10 hours*

ii. Ethical Responsibility Domain – 16 hours
iii. Mentoring/Education Domain – 10 hours
iv. Recovery/Wellness Domain – 10 hours

- 25 hours of direct supervision
- Final examination via ICRC consisting of 75 questions, is required to qualify for CPRS credential

### Building a Successful Peer Team: What to Look For in a Peer

- Minimum of 2 years of recovery
  - Active in their own recovery
- Driven to help others find their own path to recovery
  - Help seeker centered

- Compassion and empathy from having "been there"
- Knows the legal limits of confidentially
- Comfortable with public speaking
  - Sharing their own story of recovery



## Why Include Peers in your RG Program?

Peers can...

- ✓ Provide gambling addiction education to community members
- ✓ Increase awareness and help the prevention of gambling harms
- ✓ Share responsible gambling services & resources for exclusion
- ✓ Offer comprehensive support through personal lived experience
- ✓ Outreach to potential healthcare providers & organizations to integrate gambling conversations into their treatment practice



## **Peer Ethics**

Peer Recovery professionals shall maintain high standards of personal conduct and conduct themselves in a manner that supports their own recovery. Peer Recovery professionals shall serve as advocates for the people they serve.

A code of ethics is a guide of principles designed to help professionals conduct business honestly and with integrity.



## **Peer Ethics**


- Stay in Our Lane we are advocates, not counselors
- Uphold trust & respect of the person seeking help
- Maintain professional boundaries and limits of confidentiality




